On Tuesday, 5 May 2020, every twelve (12) issued Existing Shares of a par value of HK\$0.08 each in the issued share capital of the Company be consolidated into one (1) Consolidated Share of a par value of HK\$0.96 each in the issued share capital of the Company. Immediately upon the Share Consolidation becoming effective, the issued share capital of the Company be reduced by (i) rounding down the number of Consolidated Shares in the issued share capital of the Company to the nearest whole number by cancelling any fraction of a Consolidated Share in the issued share capital of the Company; and (ii) cancelling the paid up capital of the Company to the extent of HK\$0.95 on each of the then issued Consolidated Shares such that the par value of each issued Consolidated Share be reduced from HK\$0.96 to HK\$0.01.
